PROJECT DESCRIPTION AND LOCATION

The Hanford Tank Waste Treatment and Immobilization Plant (WTP) is a complex of radioactive waste treatment processing facilities designed and constructed by Bechtel National, Inc. for the Department of Energy (DOE). The facility will process the Hanford Site tank waste and convert the waste into a stable glass form.

The Project site is located in the 200 East Area of the Hanford Reservation near Richland, Washington, along the Columbia River. The site elevation varies from 662 to 684 feet above mean sea level. Ambient temperature range is -23 degrees F minimum to 113 degrees F maximum, with relative humidity of 5% minimum to 100% maximum. The project design life is 40 years.

SCOPE OF WORK

SUBCONTRACTOR shall provide all necessary expertise, manpower, material, moving apparatus/equipment, and moving vehicles to pick up, relocate, and deliver in place boxes, computers with peripherals, other equipment, furniture, (including media safes and fire-proof filing cabinets), and supplies as required.

Work may include mobilizing, modifying, and demobilizing modular workstations, office furniture, and such other miscellaneous office furnishings (Kimball, Haworth, Allsteel).

CONTRACTOR will coordinate with SUBCONTRACTOR to determine schedule, equipment, and staffing levels required to perform work.

SUBCONTRACTOR personnel are required to interface with union personnel and be cognizant of union jurisdictional rights.

SUBCONTRACTOR shall provide adequate materials, equipment, manpower, and transportation to ensure performance upon 24 hours' notice in case of emergency.

Material, Equipment and Vehicle Requirements

- Standard "Auto Bottom" moving boxes with a number sequenced interlocking lid feature in size (17.5 X 12.5 X 12.5) in quantities specified by CONTRACTOR upon request. Boxes will be furnished as new or used with a stipulated buy-back option.
- Approximately 20 wheeled computer transfer carts, sized to handle moving computer components. Carts shall be two-tiered with an open face and solid back, approximately 60"H X 18"W X 48"L.
- Shrink wrap materials for wrapping computer transfer carts (minimum size: 24"W X 11"L) in quantities as needed.
- Standard moving blankets as needed to protect computer monitors during moves.
- Standard 2-wheeled hand trucks utilized for moving boxes. Minimum quantity: 20.
- Provide or have access to one (1) set of heavy-duty safe jacks for relocating fire-rated media safes and filing cabinets.
- Provide or have access to additional vehicles/equipment to augment very large tasks or replace broken vehicles/equipment.

- Provide miscellaneous hand tools as required to include portable drills with assorted bits, screwdrivers, wrenches, hammers, etc. as needed to support work.

Minimum vehicle availability requirements:

- 1 – 48' van equipped with loading ramps
- 2 – 45' vans equipped with loading ramps
- 1 – 23' straight truck with lift gate
- 1 – 23' van equipped with lift gate

All vans/trucks shall be weather tight, in good operating order, and have fully functioning doors, lift gates, interior lighting, ramps, etc. and be lockable using padlocks.

Loaded vans/trucks may be required to be padlocked and parked overnight at designated CONTRACTOR locations due to work shift limitations.

Warehouse storage requirements:

SUBCONTRACTOR shall provide up to 1500 sq. ft. of weather protected warehouse storage upon request.

QUALITY ASSURANCE (QA) REQUIREMENTS

Programmatic Quality Assurance requirements for subcontracts performed in the WTP Jobsite will be "NP" (non-permanent or temporary work) and will not be required for this Proposal.

BIDDER REGISTRATION AND PRE-QUALIFICATION
